#### **Legislative Overview**

The 88th Legislative Session this year proved to be difficult for a number of reasons, including the enormous number of bills filed (over 8,300) and the fact that a large number of all the medical-related bills in the House went through a newly-created select committee on Healthcare Reform.

TCEP and other medical organizations fought against any bills that threatened to rollback tort reform and liability changes for Emergency Medicine. While tort reform is an issue every session, the focus on scope of practice loomed large this year. There were a number of bills that aimed to expand the responsibilities of APPs and RNs, such as allowing them to prescribe medications or perform certain procedures independently. However, TCEP and other medical organizations emphasized the importance of maintaining a collaborative healthcare team approach, where each member works within their specific training and expertise to provide the best possible care for patients. TCEP stressed that any changes to scope of practice should be carefully evaluated to ensure that patient safety remains the top priority.

Over 50 members of TCEP attended both a legislative training session last fall as well as a Legislative Day at the Capitol on April 17th. Those meetings with legislators went a long way toward sharing your experiences and helped make this a successful session. Many thanks to our Lobby Team at Imperium Public Affairs as well as the TCEP members of the Legislative Advocacy Council who spent countless hours discussing the issues at hand and testifying.

#### 2023 Legislative Session: Successes for Emergency Physicians

TCEP legislative priorities included protecting physician liability, increasing psychiatric access in the emergency department, improving telemedicine capabilities, and curtailing scope of practice expansion.

#### Successes:

Physician Liability/Tort Reform

No bills were passed that are detrimental to physician liability

Increased Access to Psychiatric Care in the ED

HB 1624 was passed and signed by the governor. Effective date: Sept. 1, 2023

Telemedicine

HB 617 was passed and signed by the governor. Effective date: Sept. 1, 2023

Scope of Practice, Value-Based Care, Ranking and Tiering Practices All bills were defeated.

**Network Adequacy** 

HB 3359 was passed and signed by the governor. Effective date: Sept. 1, 2023

Workplace Safety

SB 240 and SB 840 were passed and signed by the governor. Effective date: Sept. 1, 2023
